4b (Code:) (Expenses \$ 603,971. including grants of \$ 110,534.) (Revenue \$ 21,560.) College Orientation Program (9th-12th grade) - The Centers help students prepare for college entrance exams and explore college options. Students engage in enrichment activities such as cultural field trips, college tours and service projects.

4c (Code:) (Expenses \$ 418,592. including grants of \$) (Revenue \$ 49,685.) One-On-One (4th-6th grade) - Young professional volunteers act as individual tutors/mentors for students. Weekly sessions aim to encourage good attitudes toward learning, assist students with homework, present positive role models for students and develop in students the study habits associated with high achievers.
